#### **Schedule of Service**

## 1. Procurement Narrative Description:

The Buyer (DMM) intends to purchase the service identified in Annex A. The term of Contract shall be for 30 days unless extended by mutual agreement of the parties. The Buyer intends to award a single "Approved" seller based on conformance to the listed specifications, the ability to service the contract and the selling price.

## 2. **Procuring Activity:**

This procurement will be made by **Darul Makmur Mosque (DMM)**, located at:

DMM shall award the contract to Seller by a properly executed Purchase Order as set forth within the terms of this properly executed agreement.

#### 3. **Proposal Requirements:**

All Sellers will submit a quote which contains offers for the services and options included in this RFQ. All information presented in the Sellers's quote will be considered during DMM's evaluation. Failure to submit the information required in this RFQ may result in Seller's offer being deemed as non-responsive. Sellers are responsible for submitting offers and any modifications, revisions or withdrawals so as to reach DMM's Office designated in the RFQ by the time and date specified in the RFQ. Any offer received after the exact time specified is deemed "late" and may not be considered at the discretion of DMM. The Seller's quote shall include the following:

- a) The Quotation Reference Number,
- b) The date and time submitted,
- c) The name, address and contact of the Seller and authorised signature,
- d) Validity period of the quote
- e) Descriptions and ingredients of the menu used in the service being offered in sufficient details to evaluate the compliance with the requirement in solicitation, including product literature and/or any documents, if necessary.
- f) Special pricing instructions: price, any discount terms, special requirements or terms
- g) Payment address or instructions
- h) Acknowledgement of solicitation amendments
- Past performance information, to include recent and relevant contacts for the same or similar services; including points of contacts with relevant information

#### 4. Special Note:

The Seller, by his response to this RFQ and accompanying signatures, confirms that the terms and conditions associated with this RFQ document have been agreed to and <u>all</u> of its Annexes have been carefully read and understood and all related questions answered.





#### 5. **Form**:

Sellers must record their pricing utilising the format found on Annex A. Sellers must sign the single hardcopy submitted and send to the address listed on the cover page of this RFQ.

#### 7. Notifications and Deliveries:

Seller shall deliver the service no more than the number of sessions set forth in the contract that will be agreed by both parties as a result of this RFQ. The Buyer shall immediately contact the Seller if there will be a change in time and date of any sessions during the contract.

#### 8. **Payment Terms**:

DMM's payment modes are Cheque or GIRO to Seller ONLY. Official Invoice must be submitted to the Finance Unit for processing. Seller may propose alternative payment terms and they will be considered in the evaluation process.

#### 9. Alternative Quotes/Proposals:

Sellers are permitted to offer "alternatives" should they not be able to meet the listed requirements. Any alternative quotes shall still satisfy the minimum requirements set forth in Annex A, Service Specifications.

#### 10. Award Notice:

A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful supplier within the time acceptance specified in the offer, shall result in a binding contract without further action by either party.

#### 11. Evaluation and Award Process:

DMM will award the contract resulting from this RFQ to the responsible Seller whose offer conforms to the RFQ with the most advantageous to DMM, price and other factors considered, representing the **Best Value** to DMM.

DMM intends to evaluate the offers and award the contract without discussions with Sellers, therefore, the Seller's initial offer should contain the Seller's best terms from price and technical standpoints. However, DMM reserves the right to conduct discussions if later determined by DMM to be necessary.

The Evaluation factors will be comprised of the following criteria:

- a) **PRICE**: Lowest evaluated ceiling price (inclusive of option quantities)
- b) **SERVICE**: Items/Services shall satisfy or exceed the specifications described in RFQ/RFP Annex
- c) **PAST PERFORMANCE**: Seller can demonstrate his/her capability and resources to provide the services requested in this solicitation in a timely and responsive manner
- d) **PAYMENT TERMS**: Seller provides the most favourable payment term
